

DID THEY DIE ON THE BEACHES OF NORMANDY ON D-DAY FOR THE UNITED NATIONS?

Federal Senator William E. Jenner who took office a few years after the ratification of the United Nations Charter said that, "*a revolution is built into that Charter*". He meant that it was a blueprint for *over-throwing* our government.

Senator William Langer (No. Dakota, one of the two senators who voted against the United Nations Charter at the time it was presented for ratification, entered his views in the Congressional Record, on July 28, 1945. Sen. Langer's remarks are displayed here to dispel false information to which Americans are now being subjected. The men who died in World War II on the beaches in the Normandy invasion, *did not give their lives* "to pursue a dream" such as the New World Order, which is what has been *implied* by President Bill Clinton.

"We are the sons and daughters of the world they saved," Clinton said. "It is the job of Americans today to make "common cause" with other countries "to insure a world of peace and prosperity for yet another generation." With these statements, he urged the people of today to "not only to praise their *deeds* but to pursue their *dreams*."

Their dreams were not to see our military bases dismantled, our armed forces transferred to the communist dominated United Nations, nor to lend support to the banning of the

privately owned firearms belonging to their fellow countrymen. Those who gave up their lives when they were sent on to foreign shores believed that it was necessary in order to fulfill their oath "to support and defend the United States Constitution".

They died before the United Nations Charter was unveiled. They never read it.

They died for their mothers, their fathers, their wives and their sweethearts, not for the New World Order!

Let the record be set straight! It is up to us to go back to the principles for which they really did die, so that they did not die in vain.

HOW THE UNITED NATIONS OPERATES

When resolutions get passed at the United Nations, in the General Assembly or in the Security Council, they are transmitted to the heads of state of each country that is a member of the United Nations. It is then the obligation of the head of state of each country to see that the objectives in the resolution are achieved in his respective country by any means, style or manner possible.

In the United States the President issues executive orders which are published in the Federal Register as a mean of achieving the objectives into law. When an executive order is drafted by the president, and is so entered, if the Congress does not challenge the action

the executive order then becomes law, and is enforceable.

The direction of the United Nations resolutions are in keeping with the Charter of the United Nations. The Charter of the United Nations was imposed upon the United States by illegal treaty action. It is not the United States Constitution that is guiding our public officials; conversely, it is the Charter of the United Nations which explains the reverse direction into which America's governmental public officials are performing as they hail the New World Order.
