

**A LAW FOR CONCURRENCE BETWEEN THE FEDERAL
ADMINISTRATION AND THE STATES TO SUPPORT THE PRINCIPLE
THAT MARRIAGE MUST BE BETWEEN A MAN AND A WOMAN**

Here is a law for the Congress to pass that will make enforceable adherence of all states to the principle that marriage must be between a man and a woman. This law will eliminate the dangers of a Constitutional Amendment (which leads to a Constitutional Convention). It reads:

In order to avoid the dangers of opening a constitutional convention, while at the same time to prevent the intrusion of any branch of the federal system from usurping the rights of the states, the federal government concurs with the states that marriage has always been a fundamental principle that can be valid only if entered into by a man and a woman. This principle is applicable on a national basis and the responsibility to apply the penalty for violation of this principle shall rest with each individual state in which the violation has occurred.

Enactment of the above is a strategic and important move as it inhibits the federal government from engaging in any solution, which allows uninvited and unwelcome consequences; such as, those dangers that are possible under use of the amendment process. This law will:

- classify marriage as an important *fundamental principle (in nature)* rather than a fashion or habit;
- give the people a safe recourse to vent their opposition and produce a solution to the problem of same sex (so-called) "marriages";
- produce a concurrence by the federal system that applies this principle over every state in the nation, by which all states are obligated to abide;
- keep the federal system aware of its obligations under the Tenth Amendment to refrain from intruding on the rights of the states;
- eliminate the possibility of a constitutional *amendment* turning into a constitutional *convention* while at the same time extending national coverage for a proper measure.

The push to open a constitutional *convention* is inevitable, and it will continue no matter who is president. The "Grand Finale" is upon us: the Homeland Security (the military government necessary under the General and Complete Disarmament Law) has already been established and has every policeman in the local communities "on line" for operating a military dictatorship. The Homeland Security Agency has been a major milestone for the socialists who control the country under a militarized world government system. It was an unbelievable victory for the global socialists! Treaties being made admittedly are erasing our borders. It took Hitler only 5 minutes to overthrow the German states and go into a complete dictatorship simply because all the groundwork was done beforehand.

The need to formally write the United States "off the books" as a republic and to enlist it as a full-fledged dominion under the United Nations is next on the socialist agenda. It will require the opening of a constitutional *convention*. Since Vance Hartke failed to carry the "Department of Peace" legislation years ago, Repr. Dennis Kucinich (Ohio) is now carrying it, with all the dangers it presents if a marriage amendment is allowed. The one-world socialists are urgently seeking a method for the "write-off". Refer to the prediction of Mary Davison, a whistle blower on the activities of the United Nations. George W. Bush has a great deal of religious influence, and *he* wants "an amendment." The resolutions being made by the states to require marriage to be between a man and a woman can be used by the president as an endorsement of his effort to call for an amendment. This federal ploy must be stopped before it is beyond our control. We cannot trust our state houses alone to protect us from a constitutional convention. Once opened a constitutional convention cannot be limited to any subject says ex-Chief Justice Warren Burger, and the convention then becomes a blank check to do anything socialists wish.
